Before the commencement of the formal meeting of the Council, the Chairman paid condolences to Councillor J.I. Davies on the sad loss of his wife Menna. Members paid tribute to the community work and support Menna had given to the community over many years.

### ITEMS RAISED BY GENERAL PUBLIC IN ATTENDANCE.

The Chairman welcomed to the meeting a local resident and invited him to raise any issues relating to Council business.

The resident reported that following receipt of Planning Application No.059217 The Ridings, The Village, Babell. Heavy ground work machinery had arrived on the site. Local residents had raised concerns that ground work would be commencing before the planning application had been considered by the Planning Authority for approval.

### **RESOLVED:**

That a letter be sent from the Council to the Planning Authority making them aware of the commencement of the development before Planning Approval has been provided.

That a site visit by Planning Officers be undertaken advising the planning application of the planning consequence should development proceed and planning consent not be approved.

### 78/19 STREETSCENE SERVICES.

Mr. N. Hickie Streetscene Area Supervisor had tendered his apologise for tonight's meeting.

Councillor D. Williams reported that the recycling collection service had deposited large volumes of litter along Ysceifiog Village Road on the 12<sup>th</sup> January, 2019.

Members reported that there were still a number of outstanding large potholes on the highway within the community. Councillor T. Jones advised that he was in regular contact with Mr. N. Hickie and he would arrange for further inspections and repairs to be undertaken.

Winter Gritting of School Lane, Lixwm.

Members enquired if this road was on the winter gritting schedule. Councillor T. Jones advised that he would raise this issue with Streetscene Services.

Bryn-Y-Berthen Lane, Lixwm.

Councillor T. Jones reported that a new light had been installed which local residents had agreed would not be provided by the Council.

The Clerk advised that this may have been provided in error as part of the amenity lighting upgrading programme. The Clerk would arrange for the light to be removed and re-located.

A number of potholes were reported especially a very bad one on the B5121 Lixwm Village Road as you enter the village from Brynford. Repairs to pot holes at Rectory Close, Ysceifiog had also not been undertaken despite being reported some months ago.

Road junction to A541 road traffic signs had been knocked over.

Members reported that there had been a further 2 traffic accidents on the B541.

A BT overhead cable had fallen onto the road verge at Wheeler Hill, Lixwm.

30 mph gateway Lixwm, one of the speed signs was facing the wrong way.

Dog waste not being removed within the community of Lixwm was causing concern with some local residents. Members requested that a letter be sent to the Dog Warden Services requesting that an education event visit be undertaken to highlight the measures and facilities in place to help combat the problem.

Councillor T. Jones reported that he was in regular contact with Neil Hickie and he would bring the above matters to his attention.

### 18/19 DEMAND RESPONSIVE TRANSPORT SCHEME - NORTH FLINTSHIRE

The Chairman welcomed Mr. Steve Jones, Chief Officer Streetscene and Transportation, Flintshire County Council. Mr. Jones reported on the findings of further evaluation of the community bus scheme that had been on trial since January 2019. Due to the lack of usage and support by the local community the service was financially unsustainable and was going to be withdrawn.

A replacement service was going to be trialled from September 2019. This would be a demand responsive service (D.R.S.) Users would pre-book the service and transport would be provided to the nearest main bus hub service. The service would be free for persons holding a valid bus concession pass with charges being made for other users.

Members reported that the community bus service that had been on trial since January had been poorly marketed and the vehicles had not been branded. Mr. Jones assumed members that the vehicles for this proposed scheme are fully branded and promotion of the scheme will be extensive.

### 19/19 ENVIRONMENTAL AND PARKING ENFORCEMENT FUNDING SCHEME

Mr. S. Jones, Chief Officer, Streetscene Services, Flintshire County Council had written to the Council advising of the scheme to allow Town and Community Councils an opportunity to engage additional Enforcement Officers for their communities at a cost of £195.00 per day.

The duties undertaken by Enforcement Officers included:

- 1. Enhanced litter enforcement patrols.
- 2. Enhanced dog fouling enforcement patrols.
- 3. Enhanced fly tipping investigations.
- 4. Enhanced car parking infringement patrols.

Members considered the information provided and raised the following questions: -

- A. Which communities within Flintshire do the Enforcement Officers work in at present as no Officers have been operational in this community.
- B. How many Enforcement Officers does Flintshire County Council employ.
- C. How many enforcement actions are taken each year.
- D. Can Town and Community Councils be advised of enforcement actions being taken within their community.

E. The Council had not made any budget provision for this potential scheme for 2019/20.

Mr. Jones advised members that the proposal was to enhance the existing service that is being provided by employing additional Enforcement Officers from the contributions received from Town and Community Councils.

The Chairman thanked Mr. s. Jones for his attendance.

### 30/19 ITEMS RAISED BY THE GENERAL PUBLIC IN ATTENDANCE

A) Traffic Calming B5121 Lixwm Village Road.

The Chairman welcomed to the meeting 10 members of the public who had raised concerns over speeding traffic through Lixwm.

Also present was Mr. Darell Jones, Streetscene Area Manager, Flintshire County Council and Mr. John Morris, Community Speed Watch Manager, who had been invited to the meeting to discuss the above issue.

Members of the public sited a number of incidents of speeding traffic and accidents that had occurred in recent years. Also, the poor pedestrian infrastructure that existed did not help pedestrian movement through the village.

Councillor T. Jones advised that he had requested a traffic speeding survey to be undertaken, the findings of which would be known shortly. He further advised that Ysceifiog Community Council and Caerwys Town Council were working together on a project to improve the highway safety on Caerwys Hill and the B5121. Mr. D. Jones advised that Council Officers would assist in the project with a view of submitting the safety scheme to Welsh Government for grant funding in 2020.

Mr. John Morris advised that his organisation could provide training to community members to undertake random traffic speeding checks. A speed gun could be purchased for £100.00. the findings of the speeding checks would be sent to his organisation and letters would be sent to drivers of speeding vehicles.

Members of the public present agreed that the above proposed actions would provide a way forward. It was agreed that Councillor T. Jones would invite the residents to a project working group in September to discuss further actions.

B) Members of the public had also raised concerns over the recent spate of residential burglaries within the community. Mrs. Lisa Orhan advised that she had been in contact with P.C.S.O. Conner Freel and the Council's Clerk on this matter.

The Chairman introduced Mrs. Denise Edwards, Neighbourhood Watch and OWL Co-ordinator who had been invited to the meeting to advise residents on these matters.

Denise provided handout packs of information to all members and residents in attendance on how the community can work with her organisation to help deter criminal activity in the community.

A neighbourhood Watch Scheme could be developed and signage erected designating the area as a Neighbourhood Watch Area.

It was agreed that residents would have a further meeting with a view of establishing a neighbourhood watch scheme for Lixwm.

- C) Mrs. Lisa Orhan advised that following the success of the Lixwm Community Clean-up Day further events and projects were being considered by the community including: -
  - A) Community Orchard.
  - B) Harvest Celebrations including a Scarecrow Competition.
  - C) Provision of a community defibrillator.

Members agreed that the Council would support the events and would give further consideration upon receipt of more detailed information.

The Chairman thanked the members of the public and guest speakers for Otheir attendance and input into the meeting.
