14/25 ITEMS RAISED BY MEMBERS OF THE PUBLIC IN RELATION TO THE BUSINESS ON THE COUNCIL'S MEETING AGENDA

No members of the public were in attendance.

15/25 DECLARATIONS OF INTEREST

No declarations of interest were declared in respect of the business on the meeting agenda.

16/25 MINUTES

Proposed by Councillor P. Griffiths and seconded by Councillor J. I. Davies the minutes of the meeting held the 20^{TH} January 2025 were approved as a correct record.

17/25 HOLYWELL LEISURE CENTRE

The Chairman welcomed to the meeting Mr Mark Rowlands, Trustee of Holywell Leisure Centre Management Board. Mark provided an in-depth report on the management and development of the leisure centre facilities since its creation in 2017. Annual membership was increasing at a steady pace providing a good financial foundation for future development. A number of community-based initiatives were being delivered such as the Doctors referral scheme are well supported. Mark thanked the Council for its financial contribution which enabled new initiatives and facilities to be developed.

The Chairman thanked Mark for his attendance.

18/25 STREETSCENE SERVICES

A) POTHOLE REPAIRS

Councillor D. Ress reported that the standard of workmanship being undertaken by the Highway Authority on repairing potholes was to a poor standard. Many repairs did not last more than a couple of months. Given that resources for such repairs were at an all-time low it made uneconomical sense. Members concurred with the view that the standard of repairs needed to improve. It was agreed that this matter be brought to the Head of Streetscene Services.

B) FFORDD BABELL ROAD JUNCTION BY THE BRIDGE BABELL ROAD

Councillor A. Rowlands reported that there had been a recent vehicle accident at the highway junction with the slip road. The bridge wall appeared to have been damaged. At the slip road junction, no give-way signs or surface markings were present which may have contributed to the accident.

C) HIGHWAY REPAIRS ISSUES

The following pothole location repairs were reported: A 541 bottom of Wheeler Hill, Lixwm, Mold direction.
B5121 Lixwm Village Road corner near Ffordd Walwen Junction.
Wheller Hill, Lixwm. Boundary wall stones cascading onto verge.

D) PUBLIC FOOTPATH LIXWM

Path rear of Bodawen, Ffordd Walwen, Lixwm, obstructed by overgrown hedge.

E) BRIDLEWAY LLYFANOD, BABELL

The Council had received a complaint regarding damaged being caused by agricultural vehicles entering farmland via the bridleway. Councillor S. Copple advised that he had been dealing with this complaint for some time, and he had been advised that issue was a civil matter that the Council had no powers to intervene.

F) LIXWM C.P. SCHOOL

Councillor A. Rowlands advised that the Highway Authority had completed the re-marking of the restricted parking zone. However, vehicles were being parked causing health and safety issues for children arriving for school. It was agreed that a further request be made to Flintshire County Council for an enforcement Officer to visit the school to give enforcement guidance to

offending drivers.

Councillor A. Rowlands reported that the development at Swn Y Bedol, Babell Road, was discharging water and silt from excavations into a highway gully. Residents had reported that this had been a persistent action and feared that the gully would become blocked.
